

Greetings, fellow engineers! My name is Kelsie Clark. I am a licensed professional engineer and a member of the Western Chapter of the Missouri Society of Professional Engineers and National Society of Professional Engineers. Currently, I serve as your MSPE Vice President and I recently served as the Chair of the 2021 Fall PDH Days. I am a Senior Project Manager for Olin Winchester, the operating contractor for the Lake City Army Ammunition Plant in Independence, Missouri.

In humility and with need for Divine Guidance, I make this pledge.

To me, giving our utmost in performance, performing our work honestly to the highest professional standards, and placing the standing of the profession

before personal advantage really speaks to our integrity as professional engineers.

As stated in this creed and in the NSPE Code of Ethics, we also pledge ourselves to protect public health, safety, and welfare. If you stop and think about people's daily lives, there is almost nothing that an engineer has not touched or influenced. We have the expectation to inhabit buildings that are safe, heat and light our homes safely, transport ourselves safely, have a safe water supply and safe, sanitary waste disposal, and reliable communications networks, to name a few. The MSPE Awards Program, administered by the MSPE Awards Committee, collects nominations for the Society's annual awards programs. Below are the awards available for submission:

Extra Mile Resolution: This special award is presented at the discretion of the MSPE President to an Individual he/she determines to have performed exceptionally during his/her administration.

Hall of Fame: The MSPE Hall of Fame was developed to recognize individual engineers or friends of the profession whose personal accomplishments, awards, and activities exemplify the goals and objectives of MSPE and positively promote the professional engineering community.

PEPP Distinguished Service Award: The MSPE-PEPP presents the PEPP Distinguished Service Award to an engineer who has made an outstanding contribution to the advancement or recognition of the role of private practice in serving the public interest.

PEPP Professional Development Award: The MSPE Private Practice Professional Development Award is presented to the nominated engineering firm that has

made outstanding contributions to the advancement and improvement of the engineering profession through its employment policies and practices. The purpose of the award is to recognize those firms with the best engineering employment practices and to encourage all firms to adopt progressive policies and practices.

PEPP QBS Award: The QBS Award recognize private companies and public-sector entities at the state and local levels that use QBS methods to procure the professional services of consulting engineering firms.

Young Engineer of the Year Award: This award recognizes young members of MSPE who have made outstanding contributions to the society, the engineering profession, and their communities during the early years of their careers.

MSPE is Seeking Candidates to Serve as the Society's Vice President

APPLICATION DEADLINE: Sunday, March 6, 2022

Nominees must meet the membership requirements of a Licensed Member described in the Article 1, Section 2 of the society's bylaws as "one who holds a valid, current license or certificate of registration as a professional engineer from a state of the United States or from a district, territory or possession of the United States or from a province or territory of Canada; plus be a three-tier (NSPE, MSPE and chapter) member and be current in their membership dues payment."

Election to the position of Vice President is a one-year term with the option to ascend to the offices of President-Elect and President in subsequent years. The Vice President is an elected officer of MSPE. In the absence of the President and President-Elect, the Vice President is next in line to preside at Executive Committee and Board meetings.

Duties of MSPE's Vice President

The primary duties of this position are to attend recurring Executive Committee meetings and each Board of Directors meeting where decisions about the future of the Society are made; serve with the rest of the Executive Committee on the Budget Committee which oversees the operating budget and investment strategies of the Society.

Specific duties of the Vice President include:

1. Serve on the PDH Task Force, which organizes the programs at the Fall PDH Days scheduled in October.
2. Acting as a liaison officer where he/she will verify that committees and chapters under his/her jurisdiction have submitted reports in a timely manner and request any appropriate Board action prior to a Board meeting.
3. Complete any special assignments as designated by the President.

Members of the Nominating and Tellers Committee will review applications, interview prospects, and select one (1) candidate to be placed on the official ballot. Any applicant not selected for the official ballot, who wishes to pursue an office, may do so in accordance with MSPE Bylaws, Article VII, Section 4, Paragraph B.

Legislative Update

The 2022 Legislative Session is in full swing as hundreds of bills have been introduced since December. MSPE contract lobbyist Mark Rhoads, our Government Relations Committee, including our staff, have closely reviewed dozens of legislative bills that could impact a licensed professional engineer or a segment of the industry.

First and foremost, MSPE's government affairs work is a key aspect of the Society's mission. MSPE is the voice of licensed professional engineers in Jefferson City and our advocacy work is respected across the nation in the NSPE world. We are grateful to our members and supporting organizations for keeping MSPE strong and able to engage in this manner.

Taking a deeper look at the 2022 legislative session, there are several bills that are high on the MSPE radar. These bills are not necessarily on the fast track for passage but warrant close attention from our Government Relations Committee. If MSPE ever has an urgent request for members to contact their legislators, MSPE will send a membership alert.

Impacting Licensure

Beginning with bills related to licensure, we are closely watching HB 1900, which provides a path to licensure through three years of work experience. The bill says it pertains to people that apply for a Missouri license with career experience from another state that did not require a license, they will be granted a license. Though this bill applies to all professions, MSPE opposes such language as applicable to a licensed professional engineer. Currently, each state issues P.E. licenses, but specific projects and positions requiring an engineer license vary from state to state and MSPE opposes Missouri licenses issued to folks that did not earn a license through the traditional process required by Missouri residents. At this time, the bill has not been considered.

There are a handful of bills pertaining to land surveyors. HB 2191, introduced by Representative Don Mayhew, P.E., changes the requirements to become a land surveyor. Another Mayhew bill, HB 2364, aims to change the law regarding land survey zoning.

Impacting Transportation Funding

MSPE was pleased to see the passage of 2021's SB 262, providing a sustainable increase to transportation funding for the first time in recent memory. Unfortunately, there are several bills that aim to undo this legislation, notably included in HB 1594. SB 782 and SB 811 also propose to repeal parts of the fuel tax. MSPE joins numerous organizations, including ACEC Missouri and Missourians for Transportation Investment, working to protect the new law.

Impacting Other Infrastructure

A handful of Department of Natural Resources legislation has MSPE's eye. HB 1645, pertaining to solid waste management, relates to buffer zones in relation to residential areas. Other DNR bills, including those related to landfills, HB 2426 and HB 2512, have been introduced but not referred to committee at this time. Alternative delivery could generate discussion with the introduction of SB 758. SB 758 provides new law

relating to projects and the use of CMAR (construction manager at-risk) and design build. MSPE is working with allied associations to assess its impacts.

The Government Relations Committee, chaired by Anika Careaga, P.E., meets at least monthly to review new legislation and discuss the movement of priority bills making their way in the process. The committee is populated by MSPE members representing a broad range of disciplines. We thank Anika, Ron Black, P.E., John Briggs, P.E., Michael Purol, P.E., Tim Quinn, P.E., Gary Strack, P.E., F.NSPE, Carlos Sun, Ph.D., J.D., P.E., Mike Laney, P.E. and Mark Rhoads for their dedication.

EDUCATIONAL FOUNDATION UPDATES

CHAPTER GRANTS - ACHIEVING A FOUNDATION GOAL

Through its Chapter Grant program, the Foundation can fulfill the goals of promoting the study of engineering, professional licensure, and improving relations between engineers and the public through charitable or educational means. This fiscal year the MSPE EF provided \$15,000.00 in financial grants to five Chapters for activities and programs that met the Grant Program criteria.

The amount of grant funding available for distribution for FY2022-23 will be determined this spring as part of the annual budget development process will be directly related to the financial strength of the Foundation and the amount of its discretionary income.

The Foundation derives its income from three

revenue sources: 1) building rental; 2) income from investments; and 3) the generosity of donors. Unfortunately, building rental income has been essentially non-existent for several years because of the lack of a tenant in the lower level, reduced income from the rented space due to market pressures on rental rates, and growing building maintenance and repair costs. And although income from investments was positive this past year, as everyone knows, the market can be up one day and down the next. For these reasons, the Foundation is striving to develop a reliable donor-based that can be counted on from month to month and year to year. 


